Provided that:


- a) The students who fail to deposit the College Fees up to September 1st 2015 will neither be eligible to contest the Election nor eligible to vote in the Election.
- b) The President should be final year student.
- c) The Vice-President and the Joint Secretary should not be final year student.
- d) Be between age of 17 and 22 years as on August 16th, 2015.
- e) Have attained 75% attendance.
- f) The candidate should in no event have any academic arrears in the year of contesting the election. Any pending paper(s) will be construed as academic arrear(s). Candidates failed in the preceding academic year and/or re-admitted in the current academic year will not be eligible to contest the election.
- g) The candidate shall have one opportunity to contest for the post of office-bearer, and two opportunities to contest for the post of executive member. No candidate can contest simultaneously for more than one post.
- h) Not have a previous criminal record, must not have been convicted of any criminal offence or misdemeanor. The student shall also not have been subjected to any disciplinary action.
- i) Abide by the code of conduct, as per the Supreme Court Judgment.
- j) Every candidate is required to furnish an affidavit, along with the Security Deposit, to the effect:
 - i) That he/she does not have any previous criminal record and has not been subjected to any disciplinary action by the University/College.
 - ii) That I have not failed in the preceding academic year and/or re-admitted in the current year.
- k) The maximum permitted expenditure per candidates shall be Rs. 5000/-.
- l) Each candidate shall, within two weeks of the declaration of the result submit complete and audited accounts to the College/University authorities.
- m) Convassing time for the DUSU Elections from 03:00 P.M. to 08:00 P.M. each candidate will have not more than 04 (four) bonafide students while convassing in the College/Campus.

2. Scrutiny of Nomination Papers : Wednesday, the 2nd September 2015 at 6:30 p.m.
3. Publication of the List of duly shortlisted Candidates: Wednesday, the 2nd September, 2015 at 7:00 p.m.
4. Submission of Bank Draft as Security Deposit along with required affidavit by the Candidates : Thursday, the 3rd September, 2015 up to 6:00 p.m.
5. Last date for withdrawal of Nominations : Friday, the 4th September, 2015 up to 6:00 p.m.
6. Date of Publication of final list of candidates : Friday, the 4th September, 2015 at 7:00 p.m.
7. Date of Election : Friday, the 11th September, 2015
8. Timings of Voting : 3:00 p.m. to 7:00 p.m.
